2016 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (489) North 13th Street, west side, starting at a point 351 feet south of the southerly curb line of 1st Avenue and running 20 feet south therefrom (85 North 13th Street)
- (490) Walnut Street, east side, start at a point 87 feet south of the southerly curb line of Porter Place and running 20 feet south therefrom (93 Walnut Street)
- (491) North 15th Street, west side, starting at a point 245 feet north of the northerly curb line of 1st Avenue and running 20 feet north therefrom (135 North 15th Street)
- (492) North 17th Street, west side, starting at a point 218 feet south of the southerly curb line of Chester Avenue and running 20 feet south therefrom (243 North 17th Street)
- (493) North 17th , west side, starting at a point 210 feet south of the southerly curb line of Bloomfield Avenue and running 20 feet south therefrom (281 North 17th Street)
- (494) Willard Avenue, east side, starting at a point 249 feet north of the northerly curb line of Bloomfield Avenue and running 20 feet north therefrom (21 Willard Avenue)
- (495) East Passaic Avenue, east side, starting at a point 70 feet north of the northerly curb line of James Street and running 20 feet north therefrom (40 James Street)
- (496) Clinton Street, east side, starting at a point 189 feet north of the northerly curb line of Linden Avenue and running 20 feet north therefrom (65 Clinton Street)
