**2016 ORDINANCE AMENDMENT**

**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS**

**BE IT ORDAINED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

(497) Elmwood Avenue, north side, starting at a point 211 feet west of the westerly curb line of Grove Street and running 20 feet west therefrom ( 17 Elmwood Avenue)

(498) North 15<sup>th</sup> Street, east side, starting at a point 286 feet south of the southerly curb line of First Avenue and running 20 feet south therefrom (90 North 15<sup>th</sup> Street)

(499) North 17<sup>th</sup> Street, west side, starting at a point 90 feet south of the southerly curb line of Chester Avenue and running 20 feet south therefrom (251 North 17<sup>th</sup> Street)

(500) North 15<sup>th</sup>, east side, starting at a point 153 feet south of the southerly curb line of First Avenue and running 20 feet south therefrom (100 North 15<sup>th</sup> Street)

(501) East Liberty Street, south side, starting at a point 143 feet west of the westerly curb line of Davey Street and running 20 feet west therefrom (12 East Liberty Street)

(502) Tunbridge Place, north side, starting at a point 158 feet west of the westerly curb line of Ampere Parkway and running 20 feet west therefrom (11 Tunbridge Place)

**Section 2.** All ordinances inconsistent herewith are hereby repealed.

**Section 3.** This ordinance shall take effect upon final passage and publication in accordance with the law.
