2016 ORDINANCE NEW ORDINANCE

AMENDMENT TO THE TOWNSHIP OF BLOOMFIELD ORDINANCE ADOPTING TITLES FOR EMPLOYEES AND FIXING SALARY RANGES

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey:

Section 1. Section 2 of an ordinance entitled "AN ORDINANCE ADOPTING TITLES FOR EMPLOYEES, FIXING SALARY RANGES THEREFORE, FIXING THEIR DUTIES AND QUALIFICATIONS AND FIXING SALARIES, ADOPTED JULY 21, 1941" that has been amended and supplemented previously multiple times, is hereby further amended and supplemented adjusting the salaries of the positions listed below to read as follows:

Section 2. Definition.

"EMPLOYEES". As used in this section, the term "Employees" shall mean all classified and unclassified, provisional and permanent, union and non-union employees, who are eighteen (18) years of age or older. The term "Employees" shall not include seasonal workers for purposes of this section. The term "Employees" shall not include employees who receive salaries, or employees who are exempt under the Fair Labor Standards Act, 29 U.S.C. § 201, et seq. or the New Jersey State Wage and Hour Law, N.J.S.A. 34:11-56a, et seq., or those who are working as volunteers or interns, or "Youth Employees", those employees who are under eighteen years of age.

Section 3. Minimum Wage.

As defined in this section, all Employees of the Township of Bloomfield shall receive wages of not less than \$15.00 per hour.

Section 4. Those employees whose salaries are fixed and determined by this ordinance, terminating their services with the Township, shall be paid one-twelfth (1/12) of their annual salary for each complete month employed by the Township. Such employees working a part of a month shall be paid for the actual days worked in the final month of employment to be calculated at the rate of one-tenth (1/10) of the bi-weekly salary multiplied by the actual number of days worked in the final month of employment.

Section 5. All ordinances inconsistent herewith are hereby repealed.


Section 6. This ordinance shall take effect according to law.
