2016 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

(503) Tunbridge Place, south side, starting at a point 127 feet west of the westerly curb line of Ampere Parkway and running 20 feet west therefrom (10 Tunbridge Place)

(504) Chester Avenue, south side, starting at a point 72 feet west of the westerly curb line of Grove Street and running 20 feet west therefrom (92 Grove Street)

(505) Park Street, north side, starting at a point 46 feet west of the westerly curb line of Broad Street and running 16 feet west therefrom (6 Park Avenue)

(506) Broad Street, west side, starting at a point 49 feet south of the southerly curb line of Park Avenue and running 20 feet south therefrom (6 Park Avenue)

(507) Morton Street, west side, starting at a point 115 feet south of the southerly curb line of Belleville Avenue and running 20 feet south therefrom (2a Morton Street)

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
