2016 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND CHAPTER 254, "VEHICLES AND TRAFFIC", ARTICLE III § 254-19 "Parking, Standing and Stopped" §254-55 SCHEDULE XV: "No Stopping or Standing"

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 254 "VEHICLES AND TRAFFIC", VEHICLES AND TRAFFIC", ARTICLE III § 254-19 "Parking, Standing and Stopped" §254-55 SCHEDULE XV: "No Stopping or Standing" of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended by the addition of the following:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Bloomfield Avenue	Northwest corner of Watsessing Avenue Intersection	Starting at the curb return of the northwest corner of the intersection of Bloomfield Avenue and Watsessing Avenue and proceeding 350 feet northward along the westerly curb line of Bloomfield Avenue; and
Bloomfield Avenue	Southwest corner of Watsessing Avenue Intersection	Starting at the curb return of the southwest corner of the intersection of Bloomfield Avenue and Watsessing Avenue and proceeding 875 feet southward along the westerly curb line of Bloomfield Avenue

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
