2016 ORDINANCE DEDICATION

RIGHT-OF-WAY VACATION OF A PORTION OF HOBSON STREET

WHEREAS, Hobson Street is a public right-of way owned and maintained by the Township of Bloomfield, Essex County, New Jersey; and

WHEREAS, Clarks Pond South, designated on the municipal tax maps as Lot 26 in Block 907; is also owned and operated by the Township of Bloomfield; and

WHEREAS, a portion of the Hobson Street right of way, located at the westernmost dead-end is currently being utilized by the Township of Bloomfield for recreational purposes as part of the Clarks Pond South athletic facility; and

WHEREAS, this portion of Hobson Street has been utilized for recreational purposes for many years and is currently part of the township's Recreational Open Space Inventory; and


WHEREAS, the Mayor and Council of the Township of Bloomfield desire to permanently vacate this portion of Hobson Street and make it part and parcel of the Clarks Pond South athletic facility; and

WHEREAS, this will permanently reserve and allocate this portion of the Hobson Street right-of- way exclusively for recreational and open space purposes; and

WHEREAS, this portion of Hobson Street is specifically described in a legal description as prepared by a licensed land surveyor in that State of New Jersey, CME Associates, dated April 5, 2011 and a sketch dated April 5, 2011 and hereby made part of this Ordinance.

NOW, THEREFORE BE IT ORDAINED by the Mayor and Council of the Township of Bloomfield that the portion of the Hobson Street right-of way as described in this ordinance is

hereby vacated and made part and parcel of the Clarks Pond South athletic facility for the purpose of recreational open space.
