2016 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND CHAPTER 134, ANIMALS, ARTICLE II, Dogs § 134-21, "Animal Control Officer", WITHIN THE TOWNSHIP CODE OF THE TOWNSHIP OF BLOOMFIELD

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 134, ANIMALS, ARTICLE II, Dogs § 134-21, "Animal Control Officer", Paragraph C. of the Code of the Township of Bloomfield is hereby amended to read as follows:

§ 134-21 Animal Control Officer.

C. The Animal Control Officer shall be under the jurisdiction of the Bloomfield Police Department.
