**2016 ORDINANCE AMENDMENT**

**AN ORDINANCE TO AMEND CHAPTER 134, ANIMALS, ARTICLE I, General Animal Regulations § 134-4. "Failure to redeem impounded animals; sale; notices." WITHIN THE TOWNSHIP CODE OF THE TOWNSHIP OF BLOOMFIELD**

**BE IT ORDAINED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 134, ANIMALS, ARTICLE I , General Animal Regulations § 134.

"Failure to redeem impounded animals; sale; notices." Paragraph A of the Code of the Township of Bloomfield is hereby amended to read as follows:

§ 134-4

**Failure to redeem impounded animals; adoption; notices.**

A.

If the owner or person harboring any impounded animal or fowl does not pay the fine so imposed upon him and the charges of keeping such animal or fowl within five days after the same is impounded, it shall be the duty of the Township Administrator, or his designee, to make available such animal or fowl for adoption, giving at least five days' notice of such adoption as provided herein to the owner or person harboring the same. If the owner or person harboring such animal or fowl does not redeem the same before the time so specified in the notice, then the Township Administrator, or his designee,

B.

The notice referred to in this section may be served either by delivering it to the person on whom it is to be served or by leaving it at that person's usual or last known place of abode or by forwarding it by post in a prepaid letter addressed to that person at his usual or last known place of abode.
