2019 ORDINANCE AMENDMENT

19-61

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS (187 North 15th, 84 Waldo, 22 Chapman, 41 Patton, 16 Bay, 128 Broad, 171 Watsessing, 103 Johnson)

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

(586) 187 North 15th Street, west curb, starting at a point 96 feet north of the northerly curb line of Abington Avenue and running 20 feet north therefrom.

(587) 84 Waldo Avenue, south curb, starting at a point 353 west of westerly curb line of Grove Street and running 20 feet west therefrom.

(588) 22 Chapman Street, east curb, starting at a point 217 feet north of the northerly curb line of Hoover Avenue and running 20 feet north therefrom.

(589) 41 Patton Drive, north curb, starting at a point 250 feet east of the easterly curb line of Davey Street and running 20 feet east therefrom.

(589) 16 Bay Avenue, south curb, starting at a point 74 feet east of the easterly curb line of Chapman Street and running 20 feet east therefrom.

(590) 128 Broad Street, west curb, starting at a point 66 feet south of the southerly curb line of Park Avenue and running 20 feet south therefrom.

(591) 171 Watsessing Avenue, east curb, starting at a point 125 feet south of the southerly curb line of Berkeley Avenue and running 20 feet south therefrom.


(592) 103 Johnson Avenue, south curb, starting at a point 33 feet west of the westerly curb line of Clair Street Avenue and running 20 feet west therefrom.

Section 2. All ordinances inconsistent herewith are hereby repealed.
