2016 ORDINANCE SALARY ADJUSTMENT

AN ORDINANCE TO FIX AND DETERMINE THE SALARIES OF CERTAIN OFFICERS AND MEMBERS OF THE FIRE DEPARTMENT OF THE TOWNSHIP OF BLOOMFIELD, NEW JERSEY

WHEREAS, the Township of Bloomfield ("Township") adopted a 2015 Ordinance Amendment ("ordinance") on September 5, 2015, which set forth the salaries of certain officers and members of the Deputy Chief's Association ("Association"); and

WHEREAS, the Ordinance contained terms in error that were not reflected in the Memorandum of Agreement between The Township and the Association (collectively referred to as the "parties"); and

WHEREAS, the parties have entered in to a Side Bar Agreement to fix this error.

NOW, THEREFORE BE IT ORDAINED by the Township Council of the Township of Bloomfield, New Jersey:

SECTION 1. Effective October 1, 2012, as hereinafter indicated, the salaries of certain officers and members of the Fire Department of the Township of Bloomfield are hereby fixed and determined as follows:
