**2015 ORDINANCE AMENDMENT**

**AN ORDINANCE TO AMEND CHAPTER 75, POLICE DEPARTMENT, ARTICLE III  
"Special Law Enforcement officers" § 75-26 Residency requirements IN THE CODE OF  
THE TOWNSHIP OF BLOOMFIELD, ESSEX, COUNTY, NEW JERSEY**

**BE IT ORDAINED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 75 "Police Department" Article III "Special Law Enforcement officers" § 75-26 "Residency requirements" of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended to read as follows:

§ 75-26 Residency requirements.

Appointments to the position of Special Law Enforcement Officer with Township of Bloomfield shall be made with preference given to applicants as follows:

- 1) Retired Bloomfield Police Officer;
- 2) Bloomfield residents;
- 3) Essex County residents;
- 4) Other residents of Counties contiguous to Essex County; and
- 5) Other residents of the State.

The Police Director may request a waiver from following the listed preference from the Mayor and Council to hire any applicant the Director recommends.

**Section 2.** All ordinances inconsistent herewith are hereby repealed.

**Section 3.** This ordinance shall take effect upon final passage and publication in accordance with the law.
