2015 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

(492) Delaware Avenue, north side starting at a point 66 feet east of the easterly curb line of Ella Street and running 20 feet east therefrom (49 Delaware Avenue).

(493) N 15th Street, west side starting at a point 130 feet from the southern curb line of Chester Avenue running 20 feet south therefrom (255 N15th Street).

(494) N 16th Street, west side starting at a point 164 feet north of the northern curb line of First Avenue and running 20 feet north therefrom (129 N16th Street).

(495) Patton Drive, east side starting at a point 33 feet from the north curb line of Belleville Avenue and running 20 feet north therefrom (35B Belleville Avenue).

(496) N 16th Street, east side starting at a point 35 feet north of the northern curb line of Abington Avenue and running 17 feet north therefrom (180 N 16th Street).

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
