2015 ORDINANCE AMENDMENT

**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS**

**BE IT ORDAINED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (497) Augustus Street, south side starting at a point 120 feet from the west curb line of Mill Street and running 20 feet west therefrom (10 Augustus Street).
- (498) Baldwin Street, south side starting at a point 116 feet from the westerly curb line of North Spring Street 20 feet west therefrom (161 Baldwin Street).
- (499) Ella Street, west side starting at a point 125 feet from the north curb line of Delaware Place and running 20 feet north therefrom (84 Ella Street).
- (500) Franklin Street, south side starting at a point 144 feet from the east curb line of Parkway West and running 20 feet east therefrom (74 Franklin Street).
- (501) Myrtle Street, south side starting at a point 156 feet from the west curb line of Hinrichs Place and running 20 feet west therefrom (92 Myrtle Street).
- (502) N 16<sup>th</sup> Street, east side starting at a point 118 feet from the northern curb line of Abington Avenue and running 20 feet north therefrom (188 N 16<sup>th</sup> Street).
- (503) Park Place, east side starting at a point 50 feet from the northern curb line of Liberty Street and running 20 feet north therefrom ( 11 Park Place).
- (504) Waldo Avenue, south side starting at a point 209 feet from the west curb line of Ampere Parkway and running 20 feet west therefrom (18 Waldo Avenue).
