2015 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED by the Mayor and Council of the Township of Bloomfield,

County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4,

"Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the deletion of the following:

65 Hill Street, beginning at a point 103 feet south of the southerly curb of Bloomfield Avenue and running 20 feet there from.

161 North 16th Street, west side, starting at a point 156 feet south of the southerly curb line of Abington Avenue and running 18 feet there from.

95 North 15th Street, west side, starting at a point 253 feet south of the southerly curb line of First Avenue and running 20 feet south there from.

64 Franklin Street, south side, starting at a point 317 feet east of the eastern curb line of Parkway West and running 20 feet east there from.

51 Grove Street, east side, starting at a point 25 feet south of the southerly curb line of Beardsley Avenue and running 20 feet south there from.

10 Park Avenue, beginning at a point 141 feet west of the southern curb of Park Avenue and running 20 feet west there from.

281 North 17th Street, west side, starting at a point 205 feet south of the southerly curb line of Bloomfield Avenue and running 20 feet there from.

16 Floyd Avenue, south side, starting at a point 20 feet west of the western curb line of Ampere Parkway and running 20 feet west there from.

64 Park Avenue, south side, starting at a point 196 feet west of the western curb line of Jersey Street and running 20 feet west there from.

147 Franklin Street, south side, starting at a point feet west of the westerly curb line of Berkeley Avenue and running 20 feet west there from.

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in

accordance with the law.


