**2015 ORDINANCE AMENDMENT**

**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS**

**BE IT ORDAINED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

(484) North 17<sup>th</sup> Street, east side, starting at a point 140 feet from the southern curb line of Chester Avenue and running 20 feet south therefrom (250 North 17<sup>th</sup>).

(485) North 15<sup>th</sup> Street, west side, starting at a point 49 feet from the northern curb line of First Avenue and running 20 feet north therefrom (119 North 15<sup>th</sup>).

(486) La France Avenue, east side, starting at a point 145 feet south from the southern curb line of Bloomfield Avenue and 20 feet south therefrom ( 12 LaFrance Avenue).

(487) Barbara Street, north side, starting at a point 612 feet from the easterly curb line of Broughton Avenue and running 20 feet east therefrom (39 Barbara Street).

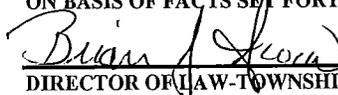
(488) Johnson Avenue, south side, starting at a point 145 feet from the westerly curb line of Skyview Road and running 20 feet west therefrom (43 Johnson Ave).

**Section 2.** All ordinances inconsistent herewith are hereby repealed.

**Section 3.** This ordinance shall take effect upon final passage and publication in accordance with the law.

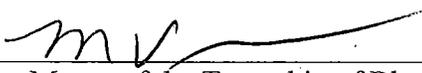
