2015 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND CHAPTER 254, "VEHICLES AND TRAFFIC", ARTICLE III "PARKING, STANDING AND STOPPING" § 254-20 SCHEDULE XVI: §254-56 "PARKING PROHIBITED CERTAIN HOURS."

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 254 "VEHICLES AND TRAFFIC", ARTICLE III "Parking, Standing and Stopping" § 254-20 SCHEDULE XVI: §254-56 "Parking Prohibited Certain Hours.", of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended by the addition of the following:

<u>Name of Street</u>	<u>Side</u>	<u>Hours/Days Time Limit</u>	<u>Location</u>
School Street	East curb	8:00 a.m. to 4:00 p.m. Monday - Friday	Starting from north curb line of Sylvan Rd and running 140 feet north therefrom
School Street		8:00 a.m. to 9:00 a.m. Monday - Friday	Starting at a point 152 feet north of the north curb line of Sylvan Rd and running 314 feet therefrom.
School Street		3:00 p.m. to 4:00 p.m. Monday - Friday	Starting at a point 152 feet north of the north curb line of Sylvan Rd and running 314 feet therefrom.

Section 2. All ordinances inconsistent herewith are hereby repealed.


Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.


