2015 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

(489) Washington Place, west side, starting at a point 250 feet from the northern curb line of Winsor Place and running 20 feet north therefrom (21 Washington Place).

(490) Beardsley Avenue, north side, starting at a point 180 feet from the eastern curb line of Grove Street and running 20 feet east therefrom (437 Beardsley Ave.).

(491) Walnut Street, east side, starting at a point 662 feet north of the northern curb line of Montgomery Street and 20 feet north therefrom ( 16 Walnut Street).

(492) Maple Street, south side, starting at a point 241 feet west of the west curb line of Spruce Street and running 20 feet west therefrom (26 Maple Street).

**Section 2.** All ordinances inconsistent herewith are hereby repealed.

**Section 3.** This ordinance shall take effect upon final passage and publication in accordance with the law.
