**2014 ORDINANCE AMENDMENT**

**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS**

**BE IT ORDAINED** by the Mayor and Council of the Township of Bloomfield,

County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4, "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the deletion of the following:

196 Jerome Place, beginning at a point on the southerly curb line, 200 feet easterly of the easterly curb line of Walnut Street and running thence 24 feet easterly.

14 Edison Street, west side, starting at a point 126 feet north of the northern curb line of Bloomfield Avenue and running 18 feet north therefrom.

34 Barbara Street, south side, starting at a point 425 feet east of the easterly curb line of Broughton Avenue and running 20 feet east therefrom.

241 North 16<sup>th</sup> Street, west side, starting at a point 149 south of the southerly curb line of Chester Avenue and running 20 feet south therefrom.

5 Canella Ct, south side, starting at a point 283 feet west of the western curb line of Harrison Street and running 18 feet therefrom.

**Section 2.** All ordinances inconsistent herewith are hereby repealed.

**Section 3.** This ordinance shall take effect upon final passage and publication in accordance with the law.
