2014 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND CHAPTER 149, "BUILDING CONSTRUCTION", ARTICLE II, § 149-8, "CONSTRUCTION FEES."

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 149 "Building Construction", Article II, § 149-8, "Construction Fees", of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended to read as follows:

§149-8. Construction Fees:

(3) Electrical Fixtures and Devices: Electrical Subcode fees.

- (a) The fees for Receptacles, Fixtures, wall switches, smoke and heat detectors, or similar items:
Each additional 25 items or part thereof \$20.00
- (b) Fees for wiring outlets and fixtures shall be as follows:
Each additional 25 items or part therefore \$20.00
- (h) Fee for HP Motors
Over 100 HP \$500.00
- (j) Sound Systems/Intercoms
Each additional 25 items or part thereof \$20.00
- (k) Pool/Spas and Hot Tubs
Each additional 25 items or part thereof \$20.00

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
