2014 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

(464) Beekman Street, north side, starting at a point 179 feet east of the easterly curb line of East Passaic Avenue and running 20 feet north therefrom (18 Beekman Street).

(465) N.16th Street, west side, starting at a point 163 feet north of the northerly curb line of Beardsley Avenue and running 20 feet north therefrom (229 N. 16th Street).

(466) Park Avenue, south side, starting at a point 196 west of the western curb line of Jersey Street and running 20 feet west therefrom (64 Park Avenue).

(467) Clinton Street, west side, starting at a point 238 feet north of the northern curb line of Linden Avenue and running 20 feet north therefrom (72 Clinton Street).

(468) Thomas Street, west side, starting at a point 150 feet south of the southern curb line of Linden Avenue and running 20 feet south therefrom (52 Thomas Street)

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
