**2014 ORDINANCE AMENDMENT**

**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS**

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

(469) Stonehouse Road, east side, starting at a point 467 feet north of the northerly curb line of Glen Ridge Parkway and running 22 feet north therefrom (173 Stonehouse Road).

(470) Lexington Avenue, east side, starting at a point 106 feet north of the easterly curb line of Fontaine Avenue and running 20 feet north therefrom (115 Lexington Ave)

(471) Orange Street, east side, starting at a point 357 feet north of the northerly curb line of Hill Street and running 12 feet north therefrom (123 Orange St)

(472) Bloomfield Avenue, south side, starting at a point 17 feet west of the westerly curb line of Sherman Court and running 20 feet west therefrom (390 Bloomfield Ave)

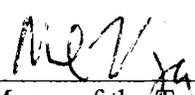
**Section 2.** All ordinances inconsistent herewith are hereby repealed.

**Section 3.** This ordinance shall take effect upon final passage and publication in accordance with the law.

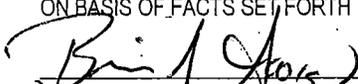
