2014 ORDINANCE BOND

BOND ORDINANCE AMENDING BOND ORDINANCE NUMBERED 03-37, AS AMENDED BY ORDINANCE NUMBERED 11-41 OF THE TOWNSHIP OF BLOOMFIELD, IN THE COUNTY OF ESSEX, NEW JERSEY, FINALLY ADOPTED OCTOBER 7, 2003 AND AUGUST 8, 2011, RESPECTIVELY, WHICH PROVIDES FOR CERTAIN REDEVELOPMENT EXPENSES, IN ORDER TO AMEND THE COSTS PROVIDED FOR UNDER N.J.S.A. 40A:2-20

BE IT ORDAINED, by the Township Committee of the Township Of Bloomfield, in the County of Essex, New Jersey (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section One. Section 6(d) of Bond Ordinance #03-37, as amended by Ordinance #11-41 of the Township of Bloomfield, in the County of Essex, New Jersey (the "Township"), finally adopted October 7, 2003 and August 8, 2011, respectively, which provides for the funding of the acquisition, redevelopment, and/or rehabilitation of properties located within areas in the Township designated by the Township Council as "areas in need of redevelopment" or "rehabilitation areas", is hereby amended to read as follows:

"An aggregate amount not exceeding \$10,000,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated costs indicated herein for the purpose or improvement."

Section Two. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.
