

2013 ORDINANCE NEW ORDINANCE

**AN ORDINANCE TO AMEND CHAPTER 254, "VEHICLES AND TRAFFIC",
ARTICLE III, "PARKING, STANDING AND STOPPING", § 254-20B**

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that § 254-20B of the Code of the Township of Bloomfield is hereby amended to read as follows:

It shall be unlawful for the owner or operator of a truck (including without limitation vans and pickup trucks), truck tractor, trailer, semi-trailer, commuter van, school buses including type I and Type II buses, omnibus vehicles (including taxis), motorized mobile homes (a vehicle equipped with sleeping, kitchen, or bathroom facilities), used for commercial purposes, as defined by N.J. Motor Vehicle and Traffic Regulations 39:1-1, to park such vehicles on any street in the Township of Bloomfield between the hours of 9:00 p.m. and 6:00 a.m. prevailing time.

This provision shall not apply to vehicles with a gross vehicle weight rating of less than 5000 lbs. except omnibus vehicles (including taxis) which shall be prohibited regardless of weight. However, Taxis shall be allowed to park for 2 hours between the hours of 9:00 pm and 6:00 am prevailing time after which they shall be prohibited from parking on any street in the Township of Bloomfield.

Section 2. All ordinances inconsistent herewith are hereby repealed.


Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
