2013 ORDINANCE AMENDMENT

ORDINANCE OF THE TOWNSHIP OF BLOOMFIELD, COUNTY OF ESSEX, NEW JERSEY ESTABLISHING THE PENALTY FOR VIOLATION OF CERTAIN PARKING REGULATIONS AND AMENDING CHAPTER 393 OF THE TOWNSHIP CODE

WHEREAS, in order to, among other things, operate and/or manage parking facilities located within the Township of Bloomfield (the "Township"), the Mayor and Council, pursuant to Ordinance 03-27 (the "Creation Ordinance") duly adopted August 4, 2003, and the Parking Authority Law of the State of New Jersey (the "State"), N.J.S.A. 40A:11A-1 *et seq.*, as amended and supplemented (the "Act"), created and established the Parking Authority of the Township of Bloomfield (the "Authority") as a public body corporate and politic of the State and an agency of the Township with all the powers, privileges, and authority conferred by the Creation Ordinance and the Act including, but not limited to the management and operation of all parking meters and related facilities located within the Township; and

WHEREAS, the purposes of the Authority are the operation and/or management of on-street and other parking facilities located within the Township and the enforcement of applicable law, ordinances and regulations as to the parking of vehicles in the Township, in order to promote the free movement of traffic and relief of traffic congestion on the streets of the Township and the improvement of conditions affecting the public safety and welfare therein; and

WHEREAS, the Authority, has passed its Resolution No. 2012-12-18-4 and Resolution No. 2012-12-18-5 (together, the "Authority Resolutions") recommending that the Mayor and Council take such action, including the adoption of an appropriate ordinance, to set forth the penalties applicable to violation of certain Township Code sections; and

WHEREAS, the Township Council desires to accept the recommendations of the Authority as set forth in the Authority Resolutions.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF BLOOMFIELD, NEW JERSEY AS FOLLOWS:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. The following is established as the penalty applicable to the corresponding section of the Township Code:

393-11 (f/k/a187-12)	Permit Parking Only	\$40.00
254:18	No Parking Anytime	\$35.00
254:19	No Stopping or Standing	\$35.00
254:20A	No Parking 9-12 or 12-3	\$35.00
254:22	1-2 Hour Parking - non metered	\$30.00
254:36	Improper or Overtime parking	\$35.00

Section 3. Section 393-11 of the Township Code is hereby deleted and replaced in its entirety with the following:

“A. Except as may be otherwise determined by the Parking Authority of the Township of Bloomfield, during the hours between 8:00 a.m. and 6:00 p.m. of each day except Saturdays and Sundays, it shall be unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or operated by such person to be parked in the permit parking area of any publicly-owned parking facility without an appropriate permit therefor properly affixed to such motor vehicle as hereinabove set forth.

B. Except as may be otherwise determined by the Parking Authority of the Township of Bloomfield, during the hours between 6:00 p.m. and 8:00 a.m. of each day, except Saturdays and Sundays, and all day on Saturdays and Sundays, it shall be lawful for any person to park a passenger motor vehicle, not including a bus, in the permit parking area of a publicly-owned parking facility without a permit or any other fee.”

Section 4. All ordinances and resolutions or parts thereof inconsistent with this Ordinance are hereby rescinded.

Section 5. If any part(s) of this ordinance shall be deemed invalid, such part(s) shall be severed and the invalidity thereby shall not affect the remaining parts of this ordinance.


Section 6. This ordinance shall take effect in accordance with applicable law.
