2013 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED by the Mayor and Council of the Township of Bloomfield,

County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4, "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the deletion of the following:

(447) Moalis Ave, north side, starting at a point 230 feet west of the westerly curb line of Clinton Street and running 20 feet north there from (65 Moalis Avenue).

(448) Almira Street, north side starting at a point 481 feet east of the easterly curb line of Broad Street and running 20 feet east there from (15 Almira Street).

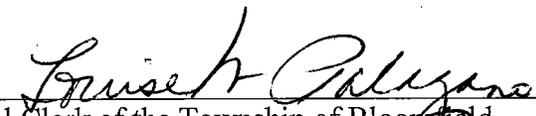
(449) Grace Street, east side starting at a point 474 feet north of the northerly curb line of Watessing Avenue and running there from (37 Grace Street).

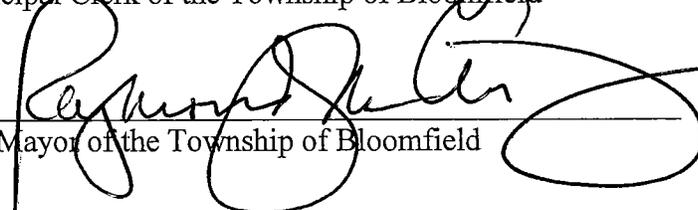
Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.

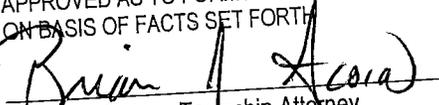
