

2013 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

13-36

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

(455) Davey Street, west side, starting at a point 151 feet south of the southerly curb line of Victor Place and running 20 feet south there from (178 C Davey Street).

(456) Chapman Street, east side starting at a point 252 feet south of the southerly curb line of Bay Avenue and running 20 feet south there from (12 Chapman Street).

(457) Baldwin Street, north side starting at a point 104 feet east of the easterly curb line of Curtis Street and running 20 feet east there from (200 Baldwin Street).

(458) Prospect Street, west side starting at a point 75 feet north of the northerly curb line of Willow Street and running 20 feet north there from (38 Prospect Street).

(459) Patton Drive, east side starting at a point 200 feet south of the southerly curb line of Davey Street and running 20 feet south there from (61-A Patton Drive).

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
