2013 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND CHAPTER 5, "ADMINISTRATION OF GOVERNMENT," ARTICLE III "Township Council," § 5-13 "Regular and special meetings," SECTION A OF THE CODE OF THE TOWNSHIP OF BLOOMFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 5, "ADMINISTRATION OF GOVERNMENT," ARTICLE III "Township Council," § 5-13 "Regular and special meetings," Section A of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended to read as follows:

§ 5-13 Regular and special meetings

A. Regular meetings. The Township Council shall meet annually for organization at 12:00 noon or at any other time decided by the Mayor elect or if there is no Mayor elect than the Mayor, on the first day of January, unless that day is a Sunday, in which case it shall meet on the next succeeding day. The Township Council may, at its option, combine the organization meeting with the first regular scheduled meeting in January. The Council shall meet regular thereafter on the first and third Mondays of each month at 7:00 p.m. except that the Council may, by resolution, dispense with one or more of the meetings otherwise scheduled for the months of July and August. When the time for any regular meeting of the Council falls on a legal holiday, such meeting shall be held at the same hour on the next succeeding day which is not a legal holiday:

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
