2012 ORDINANCE NEW ORDINANCE

AN ORDINANCE CREATING THE DOWNTOWN BUSINESS IMPROVEMENT ZONE IN THE TOWNSHIP OF BLOOMFIELD

WHEREAS, the Township of Bloomfield has established a Special Improvement District pursuant to N.J.S.A. 40:56-65; and

WHEREAS, the New Jersey Legislature has created a Downtown business improvement loan fund; and

WHEREAS, the loan program was established for the benefit of assisting municipalities that establish the Special Improvement Districts and further establish by Ordinance downtown business improvement zones; and


WHEREAS, the establishment of a Downtown Business Improvement Zone will assist of the Township of Bloomfield and the Special Improvement District in undertaking public improvements to the Business improvement zone; and

WHEREAS, the designation of a Downtown Business Improvement Zone will be in the best interest of the Special Improvement District and the Township of Bloomfield.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield in the County of Essex in the State of New Jersey as follow.

Section 1. The proposed of this ordinance is to (a) promote economic growth and employment within the business district an in particular the Special Improvement District ; (b) foster and encourage

self-help programs to enhance the local business climate; and (c) authorize permit and facilitate the Township of Bloomfield Special Improvement District and the designated district management corporation of the district to apply for and accept funds or loans from the State of New Jersey, Department of Community Affairs for Public Improvements as contemplated and defined by P.L. 1998, c 115; and

Section 2. There is hereby created and designated within the Township of Bloomfield a Downtown Business Improvement Zone that shall be co-extensive with the Special Improvement District previously established by the Mayor and Council of the Township of Bloomfield by Ordinance number No. 01-12 adopted June 24, 2001 and amended in its entirety by Ordinance No. 06-21 adopted on May 15, 2006.


Section 3. All ordinances inconsistent herewith are hereby repealed.
