**2012 ORDINANCE AMENDMENT**

**AN ORDINANCE TO AMEND CHAPTER 217, "FEES", § 217-18  
Non-applicable to Bloomfield Residents**

**BE IT ORDAINED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 217 "FEES", ARTICLE IV "Motor vehicle accidents response fee for out of town residents.", § 217-18 of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended to read as follows:

§ 217-18 Non-applicable to Bloomfield Residents/Business Owners

The fee authorized by this section shall not be collected from persons;

- (a) residing within the Township of Bloomfield as determined by their driver's license;  
or
- (b) from business/property owners who have proof of payment of a current property tax bill/or portion thereof (business owners).

**Section 2.** All ordinances inconsistent herewith are hereby repealed.

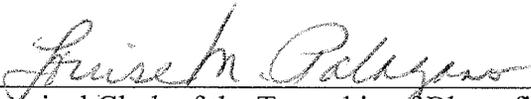
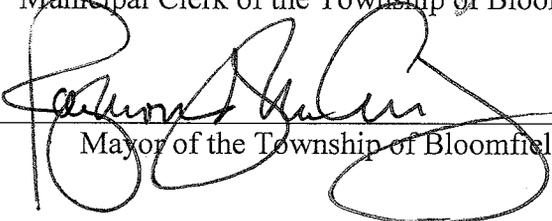
**Section 3.** This ordinance shall take effect upon final passage and publication in accordance with the law.
