

2012 ORDINANCE AMENDMENT

12-57

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

(434) N 15th Street, west side, starting at a point 156 feet south of the southerly curb line of Abington Avenue and running 18 feet south there from (161 N 15th Street).

(435) Forest Drive, west side, starting at a point 230 feet north of the nothererly curb line of Belleville Avenue and running 18 feet north there from (19 Forest Drive).


(436) Lexington Avenue, east side, starting at a point 310 feet south of the southerly curb line of Franklin Street and running 20 feet south there from (129 Lexington Avenue).


Section 2. All ordinances inconsistent herewith are hereby repealed.
