

2012 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

(438) Beardsley Avenue, south side, starting at a point 225 feet west of the westerly curb line of Ampere Parkway and running 20 feet west there from (424 Beardsley Avenue).

(439) La France Avenue, west side, starting at a point 257 feet north of the northerly curb line of Floyd Avenue and running 20 feet north there from (111 LaFrance Avenue).

(440) Ampere Pkwy, north side, starting at a point 50 feet west of the westerly curb line of Ampere Parkway and running 20 feet west there from (221 Ampere Pkwy).

(441) North 15th Street, west side, starting at a point 107 feet south of the southerly curb line of First Avenue and running 20 feet south there from (105 North 15th Street).

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
