2012 ORDINANCE AMENDMENT

Communication Operators - Amended Ordinance

AN ORDINANCE TO AMEND THE TOWNSHIP OF BLOOMFIELD'S ORDINANCE ADOPTING TITLES FOR EMPLOYEES AND FIXING SALARY RANGES

WHEREAS, the Township of Bloomfield has entered into a Collective Bargaining Agreement with the Communication Operators Association covering the period January 1, 2010 through December 31, 2013; and

WHEREAS, the Collective Bargaining Agreement sets forth the terms and conditions of employment including the salaries of employees in the Communication Operators Association; and

WHEREAS, the Director of Finance has indicated that there are sufficient funds within the Township of Bloomfield budget to cover the costs of salaries and benefits contained within the Collective Bargaining Agreement; and

WHEREAS, it is necessary to amend the Township of Bloomfield salary ordinance to reflect the salaries contained within the Collective Bargaining Agreement; and

WHEREAS, the Director of Finance has reviewed the hourly rates set forth below for the titles listed and certifies that they are accurate.

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, New Jersey that the Township of Bloomfield ordinance adopting titles for employees and fixing salary ranges is hereby amended and supplemented so that the same shall read as follows:

SECTION 2. All ordinances inconsistent herewith are hereby repealed.


SECTION 3. This ordinance shall take effect according to law.


