**An Ordinance to Amend Water Rates and Charges**

**AN ORDINANCE TO AMEND CHAPTER 556, "WATER", ARTICLE VI "Rates and Charges" § 556-38 "Water Rents, rates and prices"**

BE IT ORDAINED by the Mayor and Council of the Township of Bloomfield, New Jersey; and

Section 1. The following section of Chapter 262, entitled "Water" of the "Bloomfield Township Code," adopted November 19, 1962, is hereby amended and supplemented to read as follows:

The following rents, rates or prices are hereby established for water supplied by the Township. The same may be changed or altered, without notice, by the Mayor and Council:


**Section 2.** All ordinances inconsistent herewith are hereby repealed.
