**AN ORDINANCE TO FIX AND DETERMINE THE SALARIES OF CERTAIN OFFICERS AND MEMBERS OF THE BLOOMFIELD POLICE DEPARTMENT OF THE TOWNSHIP OF BLOOMFIELD, NEW JERSEY**

**WHEREAS**, the table of organization of the Township of Bloomfield requires the appointment of a Police Chief to perform all of the duties and responsibilities set forth in the Charter of the Township of Bloomfield, its by-laws, ordinances and the laws of the State of New Jersey; and

**WHEREAS**, after due consideration the Mayor and Council of the Township of Bloomfield determined that it is in the best interest of the Township of Bloomfield to appoint Christopher Goul as Police Chief; and

**WHEREAS**, the Township and Chief Goul acknowledge that the position of Police Chief is a full-time position and that as a condition of employment Chief Goul can hold no other employment without the written approval of the Township Administrator; and

**WHEREAS**, the Township and the Chief acknowledge that the Chief's benefits will mirror the current benefits of the other Department Heads, including, but not limited to, 21 vacation days, 12 holidays plus one floating day off, 3 personal days, medical, prescription and dental benefits, as well as his continued receipt of longevity payments; and

**WHEREAS**, the Township and the Chief hereby affirm and recognize that he will not be entitled to continuing education payments, compensatory time or holiday pay or any other benefits not currently provided to all other Department Heads with the exception of \$450 for ammunition allowance and \$850 for clothing allowance; and

**WHEREAS**, the parties recognize that the above benefits can be changed by the Township at any time in accordance with the law and Civil Service Regulations; and

**WHEREAS**, the Township must establish a salary range for the Chief.

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey:

**Section 2.** All ordinances inconsistent herewith are hereby repealed.


**Section 3.** This ordinance shall take effect according to law.




