BOND ORDINANCE AMENDING BOND ORDINANCE NUMBERED 03-37 OF THE TOWNSHIP OF BLOOMFIELD, IN THE COUNTY OF ESSEX, NEW JERSEY FINALLY ADOPTED OCTOBER 7, 2003 IN ORDER TO AMEND THE DESCRIPTION OF THE PROJECT.

BE IT ORDAINED, by the Township Council of the Township of Bloomfield, in the County of Essex, New Jersey (not less than two-thirds of all members thereof affirmatively concurring) as follows:

Section 1. Section 3(a) of Bond Ordinance numbered 03-37 of the Township of Bloomfield, in the County of Essex, New Jersey (the "Township"), finally adopted October 7, 2003 is hereby amended to read as follows:

(a) The improvements heretofore authorized and the purposes for the financing of which the bonds are to be issued is the acquisition, redevelopment, and/or rehabilitation of properties located within areas in the Township designated by the Township Council as "areas in need of redevelopment" or "rehabilitation areas" pursuant to the Redevelopment Law, and including all work and materials necessary therefor and incidental thereto, all professional and other related fees and expenses, and all relocation, demolition, environmental testing and remediation fees and expenses, all in connection with the development thereof in accordance with the redevelopment plans applicable thereto.

Section 2. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent

with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 3. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.


