2020 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND CHAPTER 5, "ADMINISTRATION OF GOVERNMENT," Part 3. Departments, ARTICLE IX "Department of Assessments" IN THE CODE OF THE TOWNSHIP OF BLOOMFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY

WHEREAS, the Township Council of the Township of Bloomfield, County of Essex, State of New Jersey (the "Township") established the Department of Assessments, the head of which shall be the Township Tax Assessor, by Ordinance, as amended November 2, 1987, and codified as Chapter 5, Part 3, Article IX in the Code of the Township of Bloomfield; and

WHEREAS, after careful examination and analysis, the Township has determined it is in the best interests of the management of the Township to dissolve the Department of Assessments and, by separate act, establish a Division of Assessments, the head of which shall be the Township Tax Assessor, within the Township's Department of Finance. **NOW, THEREFORE**

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:


Section 1. Chapter 5, "ADMINISTRATION OF GOVERNMENT," Part 3 Departments, ARTICLE IX "Department of Assessments" of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby deleted in its entirety.

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.


