2020 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:


- (601) 211 Ampere Parkway, west curb, starting at a point 68 feet north of the southerly curb line of Waldo Avenue and running 20 feet south therefrom
- (602) 109 North 15th Street, west curb, starting at a point 66 feet south of southerly curb line of First Avenue and running 20 feet south therefrom.
- (603) 10 Park Avenue, west curb, starting at a point 60 feet north of the northerly curb line of Park Street and running 20 feet north therefrom.
- (604) 268 Ampere Parkway, east curb, starting at a point 235 feet south of the southerly curb line of Chester Avenue and running 20 feet south therefrom.
- (605) 14 Evelyn Place, west curb, starting at a point 193 feet west of the westerly curb line of James Street and running 20 feet west therefrom.
- (606) 140 Baldwin Street, south curb, starting at a point 187 feet east of the easterly curb line East Passaic Avenue and running 20 feet east therefrom.
- (607) 15 Tunbridge Place, north curb, starting at a point 150 feet east of the easterly curb line of Grove Street and running 20 feet east therefrom.

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.


