2020 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4, "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the deletion of the following:

Van Winkle Street, Starting at a point 105 feet east of the easterly curb line of Davey Street and running 20 feet east therefrom (1 Van Winkle Street)

North 15th Street, Starting at a point 223 feet south of the southerly curblines of Beardsley Avenue and running 20 feet south therefrom (206 North 15th Street)

Alfred Lane, Starting at a point 346 feet north of the northerly curblines of Donald Street and running 20 feet north therefrom (24D Alfred Lane)

Morton Street, Starting at a point 62 feet from the southerly curblines of Belleville Avenue and running 20 feet south therefrom (38 Belleville Avenue)

Morton Street No. 2a, Starting at a point 115 feet south of the southerly curblines of Belleville Avenue and running 20 feet south therefrom

Ketner Street No. 15, From a point 160 feet east of Broughton Avenue east for 25 feet

Ketner Street, Starting at a point 162 feet east of the eastern curblines of Broughton Avenue and running 22 feet west therefrom (15 Ketner Street)


Section 2. All ordinances inconsistent herewith are hereby repealed.


