**2020 ORDINANCE AMENDMENT**

**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS**

**BE IT ORDAINED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (614) 22 Walnut Street, west curb, starting at a point 555 feet south of the southerly curb line of Montgomery Street and running 20 feet south therefrom. (Placard #P2238870)
- (615) 120 Grove Street, east curb, starting at a point 68 feet south of the westerly curb line of Tunbridge Place and running 20 feet south therefrom. (Placard #P2214046)
- (616) 15 Osborne Street, south curb, starting at a point 59 feet west of the westerly curb line of Broad Street and running 20 feet west therefrom. (Placard #P2234872)
- (617) 16 Beekman Street, north curb, starting at a point 147 feet east of the easterly curb line of East Passaic Avenue and running 20 feet east therefrom. (Placard #P2068377)
- (618) 214 Davey Street, west curb, starting at a point 709 feet north of the northerly curb line of Victor Place and running 29 feet north therefrom. (Placard #P2093227)
- (619) 71 Ketner Street, south curb, starting at a point 865 feet east of the easterly curb line of Broughton Avenue and running 20 feet east therefrom.
- (620) 5C Alfred Lane, north curb, starting at a point 236 feet from the easterly curb line of Donald Street and running east therefrom. (Placard #P2165646)


Section 2. All ordinances inconsistent herewith are hereby repealed.
