WHEREAS, an application is hereby made to the Commissioner of Transportation for aid under the Municipal Aid Program portion of the above Act for JFK Drive North & South Roadway Improvements - Section 1 in the Township of Bloomfield, County of Essex, State of New Jersey or such portion thereof as may be approved by the Commissioner of Transportation.


NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield formally approve the grant application for the above stated project; and
