RESOLUTION OF THE MAYOR AND TOWNSHIP COUNCIL OF THE TOWNSHIP OF BLOOMFIELD IN THE COUNTY OF ESSEX AUTHORIZING SETTLEMENT OF THE 2014 AND 2015 TAX APPEALS ENTITLED S & S AT PARK STREET, LLC V. TOWNSHIP OF BLOOMFIELD, DOCKET NOS: 015616-2014 AND 007670-2015 OF THE TAX ASSESSMENT OF BLOCK 244, LOT 19, KNOWN AS 44-58 PARK STREET IN THE TOWNSHIP OF BLOOMFIELD, ESSEX COUNTY, NEW JERSEY
